

Project Overview

U-COPE Project Mission

Develop a collaborative team of local partners, including people who use drugs, to coordinate and implement a comprehensive package of interventions using a harm reduction framework to improve healthcare access and outcomes for people who use drugs in Umatilla County, Oregon.



Desired Outcomes

- Increased access to high-coverage SSPs
- Increased linkage to substance use disorder treatment services, including medications for opioid use disorder (MOUD)
- Increased HCV, HIV, and HBV testing among persons who inject drugs
- Increased linkage to treatment for infectious complications (HIV, HBV, HCV, bacterial and fungal infections) of injection drug use
- Increase receipt of hepatitis A and B vaccine among people who use drugs

Rapid Assessment Snapshot Findings

Interview Summary

Interviewed 20 PWUD and 20 people who provide services or engage with PWUD.

- Participants provided information about facilitators, barriers, and suggestions for improving:
 - Healthcare access
 - Infectious diseases screening and treatment access
 - Substance use disorder treatment access
 - Peer services access
 - Harm reduction services access
 - Interactions with the criminal justice system

What is this checklist for?

- This checklist is a tool for organizations that provide services to people who use drugs and wish to support their clients' whole health and wellbeing.
- The U-COPE team hopes this checklist can provide resources and suggestions for practices to reduce stigma.

How should we use this checklist?

- This is a resource to help organizations reflect on what they are already doing and what they could do next to continue to create a safe, caring environment for people who use drugs.
- This list is not exhaustive, but it's a start! We encourage practitioners and organizations to continue to develop client-centered best practices.



Collaborative Leadership & Shared Successes

- Peer drop-in centers grand opening (October 2021)
- Installed new sharps container at peer drop-in center (January 2022)
- Mobile outreach trailer wrapped and ready to provide services (July 2022)
- Collaborating to address rise in Syphilis cases OWhN, Umatilla Public Health, OHA
- Regular ordering and technical assistance for Harm Reduction Clearinghouse
- OWhN hired HCV specialist peer
- OWhN hired Medical Assistant for trailer staff
- Attending 45 community events and offer harm reduction supplies, HCV screening, and peer services

Addressing Challenges, Looking Forward

- Took time to secure and set up mobile trailer: availability low and cost high
- Took time to staff the mobile trailer
- Peer centers temporarily closed
- Stigma toward people who use drugs across service sectors
- Pharmacy closure led to months of Suboxone shortages
- Increased in overdose instances with young people and in schools
 - naloxone available in schools but staff concerns about using and parental pushback
